NEW MEMBERS

Remember that you must have "8" work hours completed at the club before December 1st or your membership in the Bobwhite Club will be terminated. Currently we have 4 new members with no (0) work hours.

Regular members, there are 173 of you who have no work hours at the club in 2009. You have until December 1 to complete up to 10 hours for credit on your 2010 dues work hour assessment.

2010 OFFICERS

If you would care to run for any elected office in the Bobwhite Club, there is a signup sheet on the club bulletin board for all interested parties. Positions which are elected are President, Vice President, Treasurer, Recording Secretary, Financial Secretary, Membership Chairman and Work Hours Chairman. Members must have completed one full year of membership in the Bobwhite Club in order to be eligible to run for an elected office.

TRAP

October 18 is our last Summer Trap shoot; all make-ups must be completed at this shoot.

If you are the last person at the trap range, it is your responsibility to be certain that the traps are shut down properly and that all voice call boxes are put away. If you get them out, don't leave without putting them away unless you have made arrangements with another member who is on site that they will secure the traps and equipment when they leave.

We have had repeated problems with the traps being left open and several times the call boxes have been left out as well.

WEYER MEMORIAL LAKE

We have a leak in the area of the spillway of the Weyer (BIG) Lake. We will be lowering the lake level so that repairs can be made to the spillway before the spring. If you have a boat in the lake, you need to take it out before we drop the water level. If you need help removing your boat, contact Cliff Ludwig at 859-441-8120 and we'll take it out on October 10 during the work day.

Remember that boats may not be left on the dam and they must be stored either in the shed by the point or in the loft. Any boats stored in the loft **MUST BE** totally dry before storing them. Anyone storing a wet boat in the loft which creates water damage in the clubhouse will be held responsible for the cost and repair of the damage.
